Stephen Patterson was present to answer questions regarding the tipping fee at the transfer station. Eric Morris, a Jensen Sanitation representative was also present telling the board it was ridiculous to be raising tipping fees again that they went up 11% in 2014. Sebern also gave the board a survey previously requested by Decatur County in 2014 on brine. Sebern also told that board the County's sand salt ratio is three to one instead of two to one. Sebern also told the board if brine is run 24/7 then it is fine if you don't then it freezes up and you have trouble.

Diane Jackson spoke to the board about a possible 28E agreement between Greene/Guthrie/Audubon in which 5% of her wages would be paid by the three County's out of the general fund so that the person in her position could continue to do work such as HIPAA and verifying claims for those receiving mental health services are correct which would be work outside the region. Jackson also spoke about a Memo of Understanding. The FY16-17 budget will have to be amended if the 28E agreement is approved.

Ron Allen and Brandon Thompson explained to the board what they plan to do with the handicap parking at the courthouse. The current ramp has been grandfathered in but if there is new construction then it would have to meet current ADA requirements.
