The Guthrie County Board of Supervisors met this 7th day of July, 2020, in regular session in the meeting room at the Guthrie County Courthouse in Guthrie Center, Iowa with the following members present: Clifford Carney, Mike Dickson, Everett Grasty, Jack Lloyd and Jerome "J.D." Kuster.

Motion by Grasty second by Lloyd to approve the agenda. Motion carried: Ayes: 5 Nays: 0. Pam Lane, Human Resources Director, received notice that deferred compensation plan offered to employees is changing investment plans. The choice is to opt out or accept the changes. Motion by Carney second by Kuster to accept the changes. Motion carried: Ayes: 5 Nays: 0.

Brian Hoffman, Guthrie County IT administrator, provided two proposals to continue antivirus. Motion by Grasty second by Lloyd to approve Kaseya KSA & Bitdefender Cloud security. Motion carried: Ayes: 5 Nays: 0.

Josh Sebern, Guthrie County Engineer, presented a payroll change for Tim Masters, he's certified to spray, which qualifies him for a pay increase.

Motion by Kuster second by Grasty to approve Payroll Change Notice for Tim Master. Motion carried: Ayes: 5 Nays: 0.

Sebern provided a department update. Steve Stringham, who worked under IRVM, resigned. Sebern will be reviewing the overall IRVM department and how things will work moving forward.

Brenna Bird, Guthrie County Attorney, provided a brief department update. Due to County Attorney's collection programs the county has brought in a little over \$16,000.

Bird and Arganbright discussed HF2502, which restricts County Courthouses from prohibiting weapons, unless they make adequate arrangement to screen individuals and provide armed security personnel inside the building. Arganbright explains the reason for the change is due to 2nd Amendment rights.

Mike Lewis, Institutional Team Leader, Shive Hattery Architecture and Engineering and Sid Samuels, President, The Samuels group, Inc, provided an update on Law Enforcement Center project. They are working towards completing contract documents to go out to bid on August 20th and reviewing options to bring the project budget back down to \$8.7mill. Board agreed to use a Food Services Consultant in the design process of the kitchen. They discussed 8ft vs 6ft corridors, Board agrees to go with 8 ft wide corridors. Board agrees to add space in the mechanical room for future growth. They discussed including stairs outside of the Elevator to access the second floor within the LEC, Board would like this considered as an alternate. Lewis and Samuel explained the changes between a clear story and a sky light, smoke hatch system. Board agreed to keep the clear story, and use a smoke hatch system. Board agreed to reduce the size of the Sally Port to accommodate one vehicle vs. two. They discussed the emergency generator, Brandon Thompson, Facilities Manager, would prefer a natural gas generator. Lewis and Samuels will come back with generator options. Lewis and Samuels will return to the Board on July 21, 2020. Motion by Grasty second by Lloyd to adopt Resolution 20-01: Guthrie County Salaries and Wages Effective July 1, 2020. Motion carried on a roll call vote: Ayes: 5 Nays: 0.

Sebern opened two bids for Project L-NW3T—73-39. Benner Trucking and Dozing submitted a bid of \$22,277.50, for all three projects.

Iowa Trenchless submitted a bid of \$92,365.00. 3 contractors took plans, but did not bid. Engineer will go over bids, and return next week to award the contract.

Brad Halterman, Guthrie County Conservation Director, provided minutes from the June 8, 2020 Conservation Board Meeting. Supervisors asked if campgrounds will close early due to COVID? Halterman states as long as the weather allows, and no proclamation is ordered from the State, campgrounds will remain open as normal.

Jotham Arber, Guthrie County Public Health and Environmental Health Director, provided the compliance contract with Barker Lemar for the Guthrie County Sanitary Landfill and Transfer station for the Board to review and approve.

Motion by Kuster second by Carney to approve Proposal No. 206252: Regulatory Assistance – Fiscal Years 2021 – 2023 (July 1, 2020 through June 30, 2023) Guthrie County Sanitary Landfill & Transfer Station. Motion carried: Ayes: 4 Nays: 0.

July 21, 2020

The Board discussed a mask policy for the public coming into the Courthouse. Motion by Kuster second by Lloyd to require the public to wear face masks when entering the Courthouse beginning Wednesday July 22, 2020 until further notice. Motion carried: Ayes: 4 Nays: 0.

Josh Sebern, Guthrie County Engineer, provided project plans for Bridge Replacement BROSCHBP-C039(93) – GA-39. The bridge replacement will be approximately a 150 ft. slab, 2 ft thick and the project will go to bid October 20, 2020. No local county tax dollars will go towards this project. Estimated cost is \$1.15 mill.

Motion by Lloyd second by Carney to approve project plans for Bridge Replacement BROSCHBP-C039(93) – GA-39. Motion carried: Ayes: 4 Nays: 0.

Sebern reviewed bids, and recommended to award bidding to Benner Trucking and Dozing for project L-NW3T - 73-39. Kuster asked why the difference in bid amounts, Sebern states that the majority of Iowa Trenchless bid was put into the removal of the project.

Motion by Kuster second by Carney to award contract for project L-NW3T—73-39 to Benner Trucking and Dozing. Motion Carried: Ayes: 4 Nays: 0.

Sebern provided a department update. He stated there was more internal interest in the IRVM Manager position than he had anticipated, so he is still working to fill that role.

Brian Hoffman, IT Administrator, presented a contract to be approved with Panora Telco, to provide support as needed. The final contract is being reviewed by the County Attorney.

Hoffman stated that the guthriecounty.gov domain has been approved. The goal is to consolidate all the email systems into one. At minimum to get .gov email addresses it will cost \$4/member/month, but it's worth it to convert everyone to the same domain and avoid various fees for other domains.

Hoffman has added a VoIP system to his list of tasks. He asks that all departments hold off on getting their own phone systems so that the County can come together on one system.

Hoffman provided a brief update on the Guthrie County Domain health.

Sid Samuels, President, The Samuels Group, Inc. and Mike Lewis, Institutional Team Leader, Shive Hattery Architecture and Engineering brought updated cost estimates back to the Board from 2 weeks prior. Lewis and Samuels explained they had to increase cost of concrete due to soil conditions. Brandon Thompson, Facilities Manager, and the Board agreed they would prefer a natural gas generator to a diesel generator. The difference will cost \$40,000 for a natural gas generator, but it is easier to maintain and less cost effective over time. The total estimate of the project is coming in at \$9,345,419.00, which increased again from the discussion on July 7th. The Board expressed their frustration with the figures of the cost estimate, and asked what things could come out of the budget still. Lewis explains that he will take all the changes agreed upon and update the drawings, which will then be voted on by the Board to approve and release the final drawings. A formal presentation of the figures will come to the Board when tabulation of the bids is complete.

Leonard Shelley, David Shelley, Vera Shelley and Kevin Partlow were all present for this discussion. Shelley's want the Board to vacate a portion of Tulip Lane from the south side of Vera Shelley's property, north to where the bridge was taken out. Vera stated that if the County vacates, the road is no one's responsibility but her own. Partlow asked the Engineer why a Missouri crossing can't be put in to replace the bridge. Sebern stated the road slopes too much into the creek bed for a Missouri crossing.
